Background Information

POSITION: ESD BOARD MEMBER- ZONE 7

TERM OF APPOINTMENT: OCTOBER 21 OR NOVEMBER 18, 2025 TO JUNE 30, 2027

The objective is to appoint a Linn Benton Lincoln (LBL) Education Service District Board member that will best support the LBL Mission of serving districts, schools and students by providing equitable, flexible, and effective educational services made affordable through economy of scale.

The Board strives to be composed of Board Members with a variety of skills and perspectives including successful management, leadership, education, and community experiences.

Their duties include but are not limited to:

- Employing and evaluating the Superintendent
- Adopting policies, curriculum, and the budget
- Adopting collective bargaining agreements
- Setting the Strategic direction and approving the Local Service Plan

Appointment Requirements

TO BE ELIGIBLE FOR APPOINTMENT, THE CANDIDATE MUST:

- Have lived in the district at least 12 months prior to appointment
- Be a registered voter in the Zone boundary
- Not be an officer or employee of the district
- Be 18 years of age or older

Candidate Qualities

The Board will select the appointee with the following qualities:

- The candidate should have personal integrity, intelligence and appreciate the values of a good education.
- The candidate should be willing and capable of assuming the required responsibilities.
- The candidate should have the ability to work with others and be a champion of all our region's districts.
- The candidate should be prepared and willing to devote significant time to the study of the strengths and challenges of the ESD, the services we provide districts, as well as the state and nation at large; to be able to interpret those strengths and challenges to the electorate.
- The candidate must be willing and able to make sacrifices of their time and expertise for the benefit of the ESD.

Timeline and Procedure

The following is the timeline for selection:

- September 16, 2025 Board will review applications and select finalist candidates.
- September 17, 2025 Candidates will be notified by email.
- October 21, 2025 Finalist candidates will be interviewed at a Board Meeting, and the board member will be selected by vote.
- October 21 or November 18, 2025 New board member will be sworn in during the Regular Board Meeting.

All meetings are open to the public.

- Submit application with references and complete question responses by September 8, 2025 by 4:00 PM.
