Many GED testing centers require the GED Authorization Packet to be complete before a student may take GED preparation classes. A new GED Authorization packet will need to be submitted each academic year.

Prior to taking any GED test, home school students wishing to take GED testing:

1. Must be at least 16 years of age; *and*
2. Must obtain a GED Authorization Packet from LBL; *and*
3. Must provide the GED Authorization Packet to the GED testing site.
